Under new business we discussed the 2012 region rally schedule.

- d. Region V / Kentucky State rally August 15 - 19 Renfro Valley, Ky.
- e. Missouri State rally September 11 -16 Danville, Mo.
- f. Michigan State rally September 13 - 16 Holland, Mi.
- g. Kansas will have no rally for 2012

Lee discussed the importance of having better communication among our states to make sure when planning our rallies that we do not choose the same date as another state has already taken. This causes problems with

members wanting to attend rallies and in Lee's case he cannot attend both Missouri and Michigan. Due to Missouri selected the date that Michigan always uses Lee will be attending Michigan, and will not be attending Missouri. We all agreed that communication needs to be better and that if a state needs a certain month, just contact the state that has it and switch months or plan some time between so attending rallies would not cause a problem with those wanting to attend or having to choose between states.

Lee showed the new stickers that have been printed up that states " HRRV Club - HRRVC.org " to help promote awareness to HHRVC. They are like a bumper sticker with white back ground with blue lettering, that can be put on our units or vehicle. To cover the cost of the stickers there will be charge of \$2.00 each. Other things that were brought to the table was:

1. Emeritus Members may now vote on Chapter motions and hold Chapter office if the Chapter and the Emeritus Members agree.
2. If the Regional Director is assigned by the President or Board to attend a National Rally then that Director will be comped his/her rally fee.
3. The National Director shall assume the position of "Acting State Manager" when an HRRVC Member cannot be found for appointment to the position of State Manager.
4. The State Manager should be notified immediately by any HRRVC member who has knowledge of the death of another club member. The State Manager shall, in turn, and without delay, notify the National Chaplin and Regional Director of the death by phone. The National Chaplin is Dr. Don Fishel, 717-432-1751.
